Proof of Identity

Valid government-issued photo ID is required. If acting on behalf of another individual, legal authorization and both parties' IDs must be provided.

Fees

BGC may charge a reasonable fee for access requests. A written estimate will be provided before processing. Access will be granted upon agreement to pay the applicable fee.

Processing Time

Requests will be processed as soon as reasonably possible. If more than 30 calendar days are required, BGC will notify you in writing.

Denial of Access Request

Requests may be denied under specific legal exceptions, including risks to safety, disclosure of third-party data, or national interest. Where possible, BGC will provide redacted data or explain the reason for denial.

Withdrawal of Consent

You may withdraw consent at any time by giving reasonable notice. BGC will inform you of the consequences and cease collection, use, or disclosure unless otherwise permitted by law.
